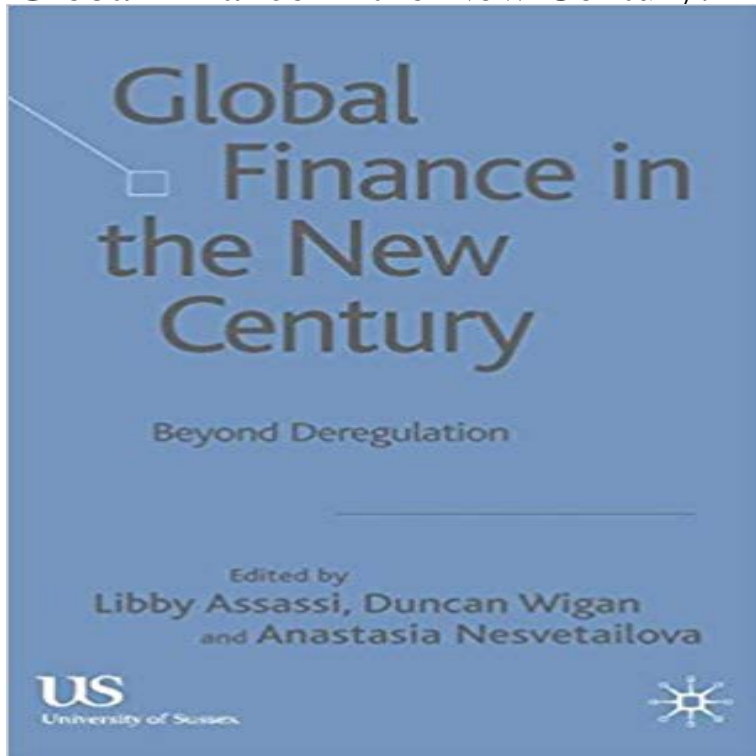


# Global Finance in the New Century: Beyond Deregulation
