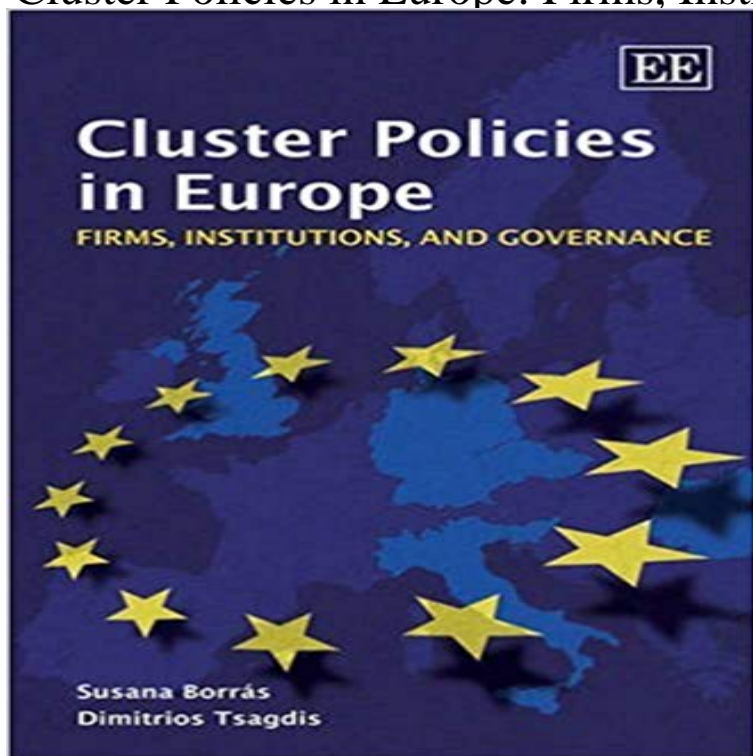


Cluster Policies in Europe: Firms, Institutions, and Governance
