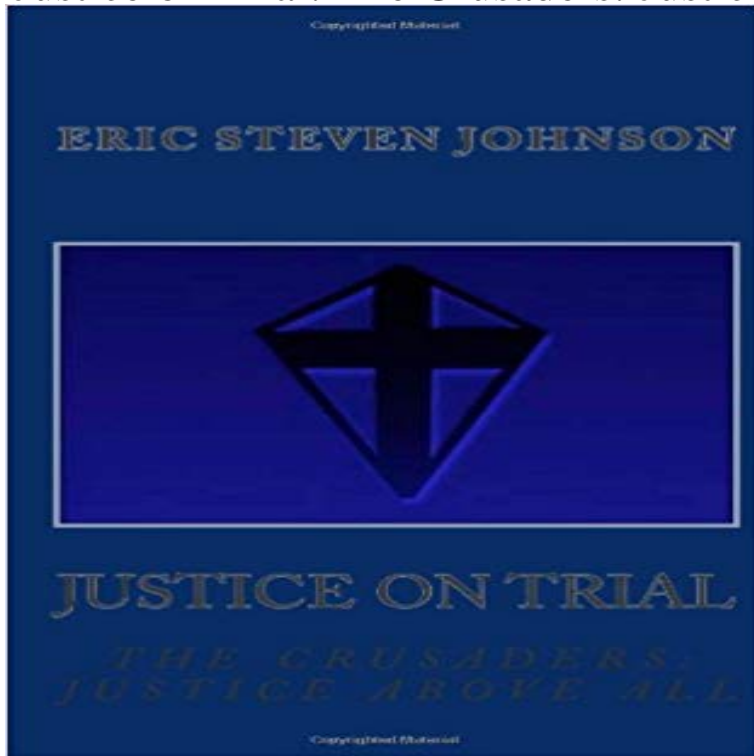


Justice on Trial: The Crusaders: Justice Above All (Volume 3)
