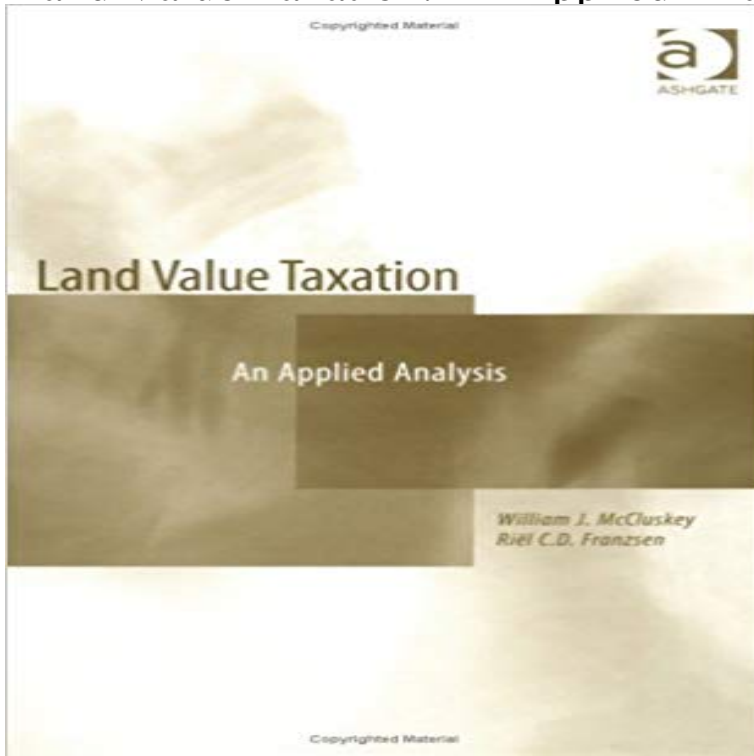


Land Value Taxation: An Applied Analysis
