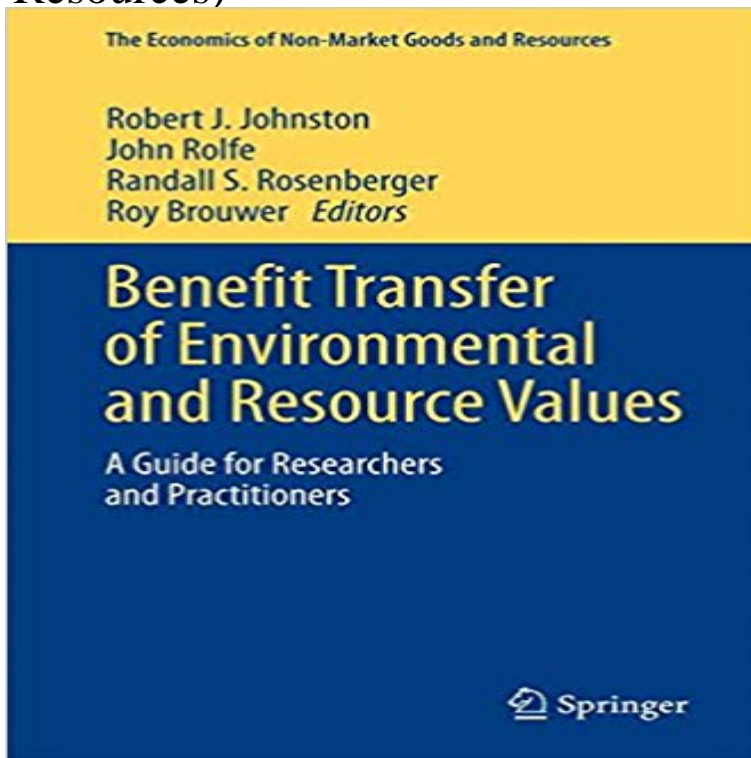


# Benefit Transfer of Environmental and Resource Values: A Guide for Researchers and Practitioners (The Economics of Non-Market Goods and Resources)
