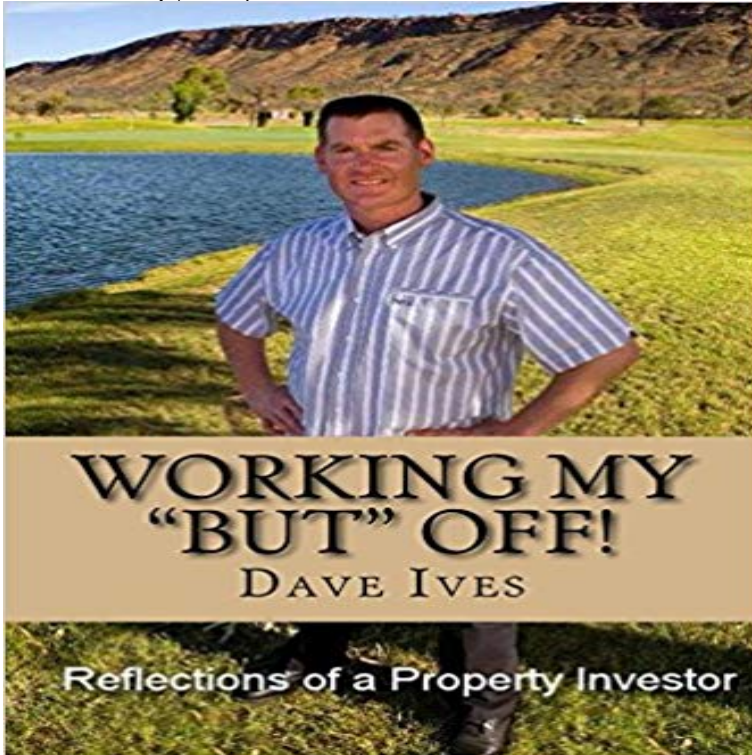


Working My BUT Off!: Reflections of a property investor.
